The Committee Chair, Ben Taylor, called the meeting to order at 7:05 p.m. and a quorum was absent.

## HOMELESS CAMPS AT 33RD & DEKUM/LOMBARD:

Presenters: Matt Caldwell, Concordia Neighbor

An overview of the 4 different camps at the intersection of 33rd & Dekum/Lombard was presented. Info for various locations was shown, ownership of various parcels, neighbors' interaction with the City, and top concerns were noted. Skler Brocker-Knapp, of the Mayor's Office, attended the meeting to speak on the City's current Impact Reduction Response efforts. Notes below:

- Camps at 33rd & Dekum/Lombard have existed for approximately 2 years. Nearby neighbors have been continually referred to various websites and bureaus regarding the status of camps.
- Peter Keller Board Report
  - Attended a listening session on 4/19 with City to learn more about clean-up efforts. The Mayor's office discussed a neighborhood liaison program that would work with the Mayor's office on targeted clean-up efforts within neighborhoods.
- Skye Brocker-Knapp (Mayor's Office)
  - Impact Reduction Metric lowered from 65-50, due to lifting pandemic protocols.
  - Sites A/B/C currently score 58 and are expected to be removed within 6 weeks.
  - Site D is located on Union Pacific Railway property and is not under City jurisdiction.
  - 100's of camps throughout the City above 50
  - People not accepting shelter even though offered.
